1. Self-image and its presentation online

Does your online activity improve or harm your self-image? Why?

2. Stereotyping and gender discrimination online

Do the Internet and social media have mainly positive or negative impact on stereotyping and gender discrimination? In what way? How can we fight stereotyping?

3. Internet safety and privacy

What are the main problems for young people regarding safety and privacy online? (Examples: cyberbullying, spreading personal info and photos without consent).

How can online safety and privacy improve?

4. Living in stress online

Do you feel sometimes stressful when you are active online? Why? What is the main cause of stress related to online activity? How can it be alleviated?

5. Access to information online, fake news

Can you distinguish between reliable and unreliable information online? How? What changes are needed to address this issue?

6. Digital activism

Do you take part (or wish to take part) in digital activism? How and about what? Do you think digital activism can bring positive changes to society?

Optional:

7. Future of employment in a digital world

Do you think that advancements in technologies like computers, AI, robotics, "Internet of things" etc. increase or decrease the prospects of today's young people to find fulfilling employment in the future?

8. Changes in education in a digital world

Is the current education system adequate to the digital society? If not, what are the main necessary changes?

Part B – alternative 2: General questions similar to Delphi1

Q1. What are the best ways to engage young people like yourself in decision-making?

- 1. New representative bodies such as "youth parliament"
- 2. Participation in committees, interest groups etc., together with adults
- 3. Direct communication between young people and decision makers
- 4. Utilization of existing "students' councils", youth organizations etc.
- 5. Fostering active groups in schools/universities/workplaces and recognition of the activists
- 6. Shared projects of self-responsibility (with family, school, etc.)
- 7. Using technologies in participatory processes (including online surveys, voting, etc.)
