## 1. Introduction

This document describes the processes and outcomes implemented during the second year of the WYRED project (García-Peñalvo, 2016b, 2017; García-Peñalvo & Kearney, 2016; Griffiths et al., 2017), M13-M24 (November 2017 – October 2018). It depicts the project situation at October 2018, M24.

The document constitutes the third deliverable of the WP9 and it follows the project management handbook (WP9\_D9.1) and the year 1 project report (WP9\_D9.2). Joint with the quality and evaluation annual report (WP10\_D10.9), D9.3 provides a picture of the project achievements and challenges faced during this period and proposes improvements to be applied during the third and last year.

The reporting activity implies an overview of the implementation of the workplan and of the products delivered (in particular deliverables, reports, publications, products of the dissemination activities); the analysis of the management results and the improvement of the management strategy, where needed.

This document is organized in four main sections:

- Outcomes and results
- Implementation of the workplan
- Impact Year 2
- Management

As indicated in the Grant Agreement, the delivery of the management report has been fixed yearly, so three versions of the document are expected at the end of each of the three project years (M12, M24 and M36). Nevertheless, updated intermediate versions of the report will be possible, taking in account that the cyclical structure of the WYRED project processes (WYRED Consortium, 2017c, 2017d) does not always fit to the traditional organization of work packages and reporting.

A complete financial report has been provided in M19, at the end of the first reporting period (RP1, M1-M18), joint with the periodic technical and financial report (GA 20.2 and 20.3, p.29).

**Abstract:**

The emergence of the young as a distinct social group, and their slowly increasing empowerment through the availability of digital technology, has brought with it an understanding that they have a key role to play in the digital society, as drivers of new behaviours and understandings. However, their active participation in society is not reflected sufficiently in policy and decision-making, especially in relation to digital issues. Because of this, they are not well represented and unheard, and this makes it hard for research and policy to identify and understand their needs. These issues are further complicated by the fact that the group is a swiftly moving target, it is as heterogeneous as the wider society, and young people can be unwilling to be subjects of research.

The WYRED project (netWorked Youth Research for Empowerment in the Digital society) aims to provide a framework for research in which children and young people can express and explore their perspectives and interests in relation to digital society, but also a platform from which they can communicate their perspectives to other stakeholders effectively through innovative engagement processes. It will do this by implementing a generative research cycle involving networking, dialogue, participatory research and interpretation phases centred around and driven by children and young people, out of which a diverse range of outputs, critical perspectives and other insights will emerge to inform policy and decision-making in relation to children and young people's needs in relation to digital society.

The project is informed by the recognition that young people of all ages have the right to participation and engagement. It has a strong focus on inclusion, diversity and the empowerment of the marginalised. The aim is to replace the disempowering scrutiny of conventional research processes with the empowerment of self-scrutiny and self-organisation through the social dialogue and participatory research.

## 2. Outcomes and Results of the Year 2

### 2.1. The WYRED cycle

According to the project proposal, the WYRED project is designed to work in cycles (WYRED Consortium, 2017c, 2017d). The project work plan involves 10 work packages. The WP1 involves the **definition of the different processes** involved in the research cycle, and the WP2 is devoted to the preparation and implementation throughout the project of the **inclusion strategy** (WYRED Consortium, 2017a, 2018a), the WP3 focuses on the development of the **WYRED platform** (García-Holgado & García-Peñalvo, 2018; García-Peñalvo, 2016a; García-Peñalvo & Durán-Escudero, 2017; García-Peñalvo, García-Holgado, Vázquez-Ingelmo, & Seoane-Pardo, 2018; WYRED Consortium, 2017b), which will be used throughout the project as the space in which the activities and interaction take place. After these first three preparatory WPs, **the next 5 cover the full cycle of activity in WYRED**. This starts with **network building** in WP4, in which the children and young people who will participate in the research cycle are attracted and engaged and the principal themes that represent their concerns are identified. The next work package (5) focuses on **social dialogue** around these themes which will explore the themes to identify key research questions relating to the digital society that concern children and young people. In the subsequent work package (6) these children and young people, supported by the partners, will focus on designing and implementing **research activities** to explore these questions and issues in a range of different ways. WP7 focuses on the **interpretation and evaluation** of the process and its results in the production types by the young research participants and the partners, of different formats and artefact that will be used to present the results, principally insights and recommendations to different target groups at policy level and in the wider society. The final phase of the cycle in WP8 focuses on the **dissemination and exploitation** of these results, though this work package runs throughout the project engaging in the valorisation of the WYRED

activity through workshops, event participation, online activity and an association. **These 5 work packages form a cycle** that is aimed to generate insights relating to the perspectives and concerns of children and young people in relation to digital society. The WYRED cycle is supported by 2 other work packages focusing on **management** (WP9) and **quality** (WP10).




Figure 1: Relation between the workpackages according to the project proposal (GA Part B p.29)

- Assuming an overlap between the first cycle and the second one. So, the first cycle followed the scheduling described in the proposal (December 2016, M2 – February 2018, M15) and it was considered as an “experimental” cycle and the second started before the period initially scheduled on July 2017 with the implementation of the initial networking actions and social dialogues and continued the activities until August 2018, M22, where the more active period was from September 2017 to May 2018 following the school year. It had the benefit that, as well as addressing the schedule issue, it allowed the project to implement a full cycle before the end of the 2<sup>nd</sup> project year, on time for the second annual reporting, and to have a third complete cycle to be implemented in the 3<sup>rd</sup> project year.

The periods of the 3 cycles are:

- WYRED 1<sup>st</sup> cycle: December 2016, M2 – February 2018, M15.
- WYRED 2<sup>nd</sup> cycle: July 2017, M9 – August 2018, M22 (main activities took place from September 2017 to May 2018 following the school year).
- WYRED 3<sup>rd</sup> cycle: September 2018 - August 2019.

At the end of the 2<sup>nd</sup> year, we can state that the deviations suffered during the first year have now been corrected and the project is back on schedule.

The first deviation was related to the timing between countries in cycle 1. The different realities and cycles of young people’s activity in different countries caused complications with the close synchronised planning. The cycle has been adapted, principally by allowing a greater degree of flexibility, and this has made it easier to run the cycle in the different countries. In the previous reviews this approach was considered appropriate.

The platform suffered some delays. Although the decision was taken not to develop from scratch, the complexity of the emerging WYRED approach and the requirements involved, especially the issue of privacy and participant protection, caused considerable complications in the process of development. It is important to mention that though these delays have had some repercussions in relation to the international dimension of the project, the platform design has involved a very careful consideration of data security and ethics issues, and a progressive simplification of the processes involved, in order to improve the personal experiences with online interaction in the platform. It is now considered to be appropriate for the work of WYRED and is running with a very large target group with considerable diversity in terms of ages, languages and communication



styles. Although it is early to be sure, and the challenge of “competing” with existing media that young people are used to using remains, there are good indications that the platform can provide a useful safe space for WYRED activity.

The other deviation was due to the delay in the advisory board set-up, which has now been remedied, and all related meetings took place both online and face to face and the reports have been delivered.

Now that the infrastructure is fully in place and the lessons learned from the first cycle implemented and the recommendations received in the technical review report (31/07/2018), the project is well positioned to achieve its objectives.

## 4 Impact Year 2




Figure 4: WYRED Social media dissemination strategy

### 5.1.2 Internal communication mechanisms

#### Internal communication platform

Redmine is an open source flexible project management web application, which allows to keep a daily monitoring of the implementation of the tasks and provides spaces for internal communication and collaborative work.

At the moment, the WYRED management on Redmine is organized in a main project space where all the partner teams have access to: the GANTT, the workpackages forums, the wiki, the storage of the project documents, etc.; and a subproject space devoted to the technical tasks related to the WYRED platform development and restricted only to coordinators and software developers.




Figure 5: Redmine. Management of the project implementation (all partners) - GANTT

The initial purpose that led to the choice of Redmine is based precisely on the need to ensure a space for the integral management of a complex project like WYRED both for the implementation



of the WYRED cycles of discussion and social research and for the constant development of the functionality of the platform, which evolves according to the needs of the user community and the input of the partner teams.

Even if during the first project year the experiences of use of Redmine have produced different results among the partners, during the 2<sup>nd</sup> year the communication through the platform was really fluid.

Taking this into account, the coordinator took care to keep updated the documentation and the work plan on Redmine and interactions among partners were maintained in the forums. Other tools were adopted to support the performance of collaborative tasks and bilateral or in small groups communications, following the partners' inputs and digital habits.

Collaborative spaces have been enabled in Google Drive in particular for monitoring networking and dissemination actions, Padlet walls for management issues, and the internal communication has been supported by e-mail and video conferencing.



These guidelines are helping the coordinator to apply properly the law and to avoid unintentional non-compliance in the developing of the project platform.

## 6 Conclusions

The description of processes and outcomes implemented during the WYRED project 2<sup>nd</sup> year outlines a solid project, which counts with a good management infrastructure.
